Part I – Programme Introduction

1. Background

Among the 17 UN SDGs, climate change is one of the key global issues connected to sustainable challenges. It has significant impact on public safety, water and food security. With a view to combating climate change, Wofoo Social Enterprises (WSE) established Hong Kong SDG Hub in 2020. Hong Kong SDG Hub serves as one of the first SDG platforms in Hong Kong for youths and entrepreneurs to share and exchange relevant experience through one of the key initiatives - “Climate Action Recognition Scheme (CARS)”.

2. Aims

- 1 Spark interest and fuel a spirit of youth in addressing climate change issues
- 2 Incubate start-ups and community which can create positive change for our climate
- 3 Facilitate cross-sector collaboration and act as a networking platform for climate related issues in Hong Kong

3. Overview

CARS is an entrepreneurship programme initiated by Hong Kong SDG Hub, co-organized by the Environment Bureau and sponsored by The Hongkong and Shanghai Banking Corporate (HSBC). The Scheme recognizes and invests in innovative and outstanding start-up ideas which take actions in combating SDG-related climate change problems.

CARS provides holistic training in entrepreneurship and innovation, mentorship support, publicity and networking platforms, seed fund and acceleration fund to young “climate shapers” who are determined to act on and transform climate awareness into climate actions and solutions.

4. Strategies

Inspire

Through providing training workshops and a platform where they can seek advice and guidance from relevant industry experts, CARS hopes to inspire and assist participants in honing their basic entrepreneurial skills and developing their creative capacity.

Incubate

With the platform established, cross-sectoral resources and networking opportunity will also be matched to these climate shapers, in order to expand their horizon in the industry of sustainable development and actualize their climate change solutions.

Invest

CARS will award HKD\$120,000-HKD\$180,000 per cohort to selected projects for developing and scaling up the prototype. Various events will also be arranged for selected participants to pitch and showcase their innovative climate actions to potential investors.

Part II – Recognition Scheme Details

5. Theme

We welcome any potential and valuable solutions that may make an effort in combating climate change effects and enhancing climate resilience in Hong Kong. The eligible ideas should focus on achieving **UN SDG 13: Climate Action**.

6. Leagues & Eligibility

League 1 - Idea Stage

- For teams which are looking for realizing their ideas of climate solutions to prototypes

Application Deadline:

- 30 December 2021

Notes:

- Each application should consist of one to four core team members (including the team leader), who are between aged 18 and 40 as of application deadline.
- All core team members can only join ONE league, join ONE team under that league, and submit ONE application during the application period.
- Teams may comprise of members from different institutions and academic background.
- Each application should submit a Hong Kong-based climate change solution.
- All teams should acquire endorsement from one tertiary institution / youth entrepreneurship organization by filling in the CARS endorsement form or by submitting a formal reference letter. Applications without endorsement or references will not be accepted.
- Start-ups and companies which are already registered and incorporated are NOT eligible for "Idea Stage" League. Winners of any incubation and/or entrepreneurship programme are also NOT eligible for "Idea Stage" League, unless special approval from the Organizer is granted.

Interested applicants should get endorsement from a department or a unit under any higher education institutions or youth entrepreneurship organizations in Hong Kong. In order to ensure a smooth verification process of endorsement, applicants are highly recommended to get endorsement from the units (these units have partnerships with CARS) listed below. 9. Training & Mentoring

Pre-Application Workshop (Nov 2021)

Pre-application workshop will be arranged for interested potential participants before the application. The workshop aims to help the participants on the overview on the environmental problems and how to create an effective impact on climate change, in order to acquire insight and generate innovative solutions for solving climate change.

HKSTP IDEATION (Jan – May 2022 onwards)

2021-22 CARS is proudly supported by HKSTP IDEATION, which is one-year startup support programme for entrepreneurs to learn the fundamental skills they need to kickstart the business.

Through the supports from HKSTP, participants are able to learn such as how to write a persuasive business plan and raise venture capital, gain a fundamental understanding of business management and the entrepreneurial ecosystem of Hong Kong, etc.

Eligible teams are required to achieve a designated target at three different stage, and will receive an amount of rewards from the HKSTP.

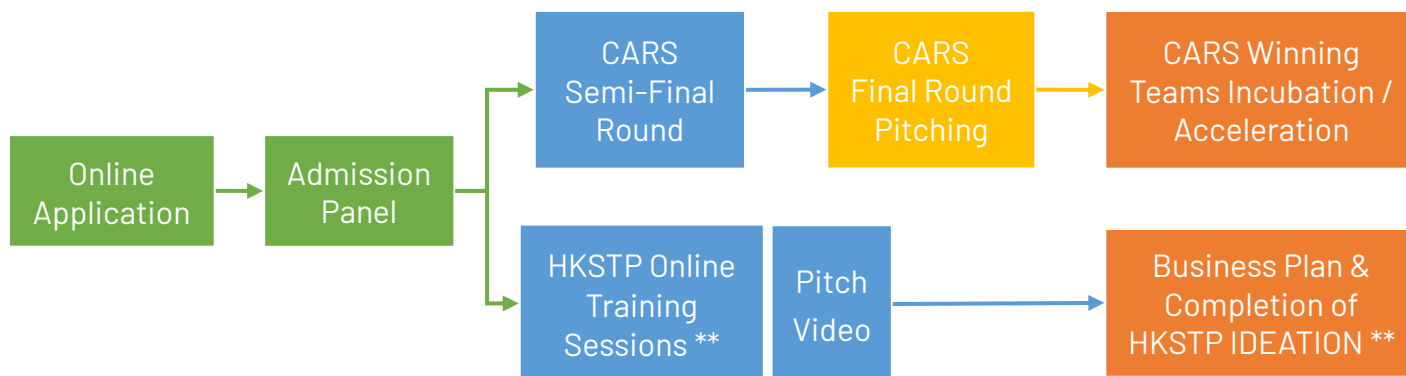
- 1st milestone - formulating a development plan and market identification
- 2nd milestone - attaining the expected goal(s) and customer validation
- 3rd milestone - realizing the plans with a prototype

Note: Scale-up Stages teams whose start-ups incorporated for more than two years but less than three years are not eligible for HKSTP IDEATION. They will not be entitled of resources from HKSTP, but will also be exempted from the online training sessions by HKSTP during the assessment process.

Mentorship & Pre-Pitch (Jan – Apr 2022)

Mentor consultation and pre-pitch sessions will be arranged for teams to consult and pre-pitch the project idea to the industries experts and innovative pioneer. Teams can seek advice and guidance from the industry high achievers and expand the networks in the industry.

10. Assessment Process



***Start-ups incorporated for more than two years but less than three years are not eligible for HKSTP IDEATION*

Stage 1: Application (Oct 2021 – Jan 2022)

1.1 Online Application (Oct 2021 – Dec 2021)

Eligible applicants should submit the following documents before the application deadline:

1. Online Application Form

- Applicants should fill in the application form online. Only online application is accepted.
- Applicants should also upload the below documents in the online application form.
- Each file would be uploaded should be within 10MB.
- Please name all the uploaded files after the team or start-up name (e.g. Wofoo_EndorsementForm).

2. Concept Note (Idea Stage) or Detailed Proposal (Scale-up Stage)

- The concept note should be no more than two pages (cover page not included in the count limit).
- The detailed proposal should be no more than eight pages (cover page not included in the count limit). Teams may choose to include infographics in the detailed proposals.
- The concept note or detailed proposal should be written in English, numerated, and saved in a Microsoft Word or PDF file format.
- Clicking [HERE](#) to download template of concept note, and [HERE](#) to download detailed proposal

3. Appendices (if applicable)

- Idea Stage teams may attach appendices not exceeding two pages, if possible.
- Scale-up Stage teams may attach appendices not exceeding five pages, if possible.

4. Endorsement Form / Reference Letter

- All applications must secure an endorsement (verified with an official organization chop on the form) from tertiary institutions or youth entrepreneurship organizations.
- Clicking [HERE](#) to download the endorsement form.
- A formal reference letter may be submitted in lieu of the verified endorsement form.

5. Supporting Documents

- Resumes of all core members (if applicable)
- Certificate of Incorporation under the Companies Ordinance (applicable to start-ups)
- Proof of matched funding or provision of any additional investments (applicable to winners of any entrepreneurship programme)
- Intellectual property document (if applicable)

1.2 Admission Panel (Jan 2022)

Applicants shall attend an admission panel meeting in Jan 2022. Each team has not more than 7 minutes to pitch their ideas. More details will be released closer to the meeting date.

Stage 2: Capacity Building and Assessment (Jan – Mar 2022)

2.1 Admission to HKSTP IDEATION (Jan 2022)

Admitted semi-finalists will automatically be admitted to HKSTP IDEATION and achieve the 1st milestone. They shall attain the following requirements from HKSTP and will be rewarded \$10,000 for starting to develop or scale up the prototype.

1. Incorporate a limited company in Hong Kong (applicable to Idea Stage teams only)
2. Prepare a company bank account (applicable to Idea Stage teams only)
3. Prepare a milestone plan (Click [HERE](#) to download)

Note: For Scale-Up Stage teams whose start-ups incorporated for more than two years but less than three years (Scale-up Stage):

- They are not eligible for HKSTP IDEATION and will not receive any monetary resources.
- They will be exempted from the online training sessions by HKSTP.
- CARS will evaluate their suitability for admission into other HKSTP incubation programmes after their completion of CARS.

2.2 Semi-Final Assessment (Mar 2022)

1. Attendance of Online Training Sessions by HKSTP

- Teams must complete all 10 designated online training sessions by HKSTP IDEATION before the semi-final assessment deadline in Mar 2022.
- Teams shall complete survey after training, or the training attendance record will not be valid.
- Scale-Up Stage teams whose start-ups incorporated for more than two years are exempted from the online training sessions by HKSTP.

2. Detailed Proposal

- Idea Stage teams shall submit detailed proposal no more than eight pages (cover page is not included in the count).
- Scale-up Stage teams may choose to revise the detailed proposal. The revised one should also be no more than eight pages (cover page is not included in the count).
- The detailed proposal should be written in English, numerated, and saved in a Microsoft Word or PDF file format. Teams may choose to include infographics in the detailed proposal.
- Please name all the uploaded files after the team or start-up name (e.g. Wofoo_DetailedProposal).
- Any other supplementary information and appendices should not exceed five pages, if possible.

3. Pitch Video

- The video length should be five minute, covering product intro, technology uniqueness, commercial value / prototype.
- Teams can use images, graphics, animations, and clips in the video to present the idea.
- The video can be presented in either English or Cantonese; English subtitles are preferred.

4. Milestone Progress Update (Click [HERE](#) to download)

All approved semi-finalists (except Scale-Up Stage teams whose start-ups incorporated for more than two years) will be rewarded \$40,000 for the attainment of the above requirements from HKSTP and achievement of 2nd milestone.

6 semi-final teams from Idea Stage and 6 from Scale-up Stage with outstanding performance will also be selected by CARS judging panel to admit to the final round.

Stage 3: Pitching (Apr – May 2022)

3.1 Public Pitching (Apr 2022)

Finalists will get an opportunity to set up a pop-up station at public event to showcase their project ideas to the public and green groups. Teams could test their ideas and gauge market reaction through the public voting session:

- All promotional materials for the pop-up station should be prepared by the teams. Teams are encouraged, but not required to prepare the display materials in Traditional Chinese.
- Members of the public will have a chance to cast their votes for their favorite initiative. The popular ideas will be given bonus scores.
- All team members must be present at the pop-up station. The whole team will be disqualified if any team member is absent without prior and official approval from the Organizer.
- More details will be released closer to the event date.

3.2 Grand Final (May 2022)

Finalists will deliver a pitch to industry experts, business representatives and potential investors, who will act as judges at the Grand Final. Judges would offer feedback and insight on how teams may refine their business model and craft a unique business proposition.

Format:

- Finalists will have 10 minutes to pitch, followed by a 10-minute Q&A session.
- Teams can deliver the pitch in either Cantonese or English.
- Finalists should hand in their presentation deck 7 days before the Grand Final.
- All team members must be present at the Grand Final, but not every team member is required to present at the pitch. The whole team will be disqualified if any one member is absent without official prior approval from the Organizer.

Materials should be prepared:

- Finalized presentation deck
- Finalists may choose to prepare and present videos and other multimedia files during their pitch.
- Finalist may also choose to showcase their prototype showcasing (if any) during the pitch.

All finalists will also get an opportunity to showcase their project ideas to the invited guests during the Grand Final. More details will be released closer to the event date.

Stage 4A: Winning Teams Incubation / Acceleration (May 2022 onwards)

After the Grand Final, 2 winning teams will be awarded HK\$120,000 and 3 winning teams will be awarded HK\$180,000 in two phases. The first payment will be made after winners submit a budget plan, a document outlining milestones and a signed agreement. The final payment will be issued to winners, subject to the examination and verification of project reports and the delivery of pre-set project targets.

Stage 4B: Completion of HKSTP IDEATION (before Dec 2022)

No matter winning or not, teams can complete the HKSTP IDEATION and be rewarded \$50,000 for the attainment of the below requirements from HKSTP and achievement of 3rd milestone:

- Business plan in Microsoft Powerpoint format
- Milestone progress report (Click [HERE](#) to download)
- Approval letter from HKSTP incubation programme

Potential IDEATION participants will be recommended to apply for other HKSTP incubation programmes for further support on their entrepreneurial journey.

Note: Scale-up Stage teams whose start-ups incorporated for more than two years but less than three years are not eligible for HKSTP IDEATION. CARS will evaluate their suitability for admission into other HKSTP incubation programmes after their completion of CARS based on their performance in semi-final and/or final round.

12. Rules & Regulations

Application

- Participants should submit all the documents before the deadline. Late submissions will not be considered.
- Participants should submit supplementary information for further consideration upon the Organizer's request.
- Participants should attend all compulsory workshops, trainings, and activities organized under CARS. The whole team will be disqualified if a team member is absent from any compulsory event without official prior approval from the Organizer.
- If in double, team leaders should liaise with the Organizer directly on the matters relating to CARS.

Copyright

- All participants shall warrant that the submitted idea/proposal is the original idea of their team. Participants and teams found to have committed copyright infringement in their work will be disqualified.
- Participants shall be liable for any violation of any copyright laws. The Organizer is not responsible for any direct or indirect copyright infringement in participants' works.
- Participants will be responsible for taking proper steps to protect their intellectual property.
- The Organizer may make copies and recordings of the submitted documents or materials for CARS. The Organizer reserves the right to use or publish any materials related to CARS for promotion and publicity purposes.

Judging

- The decision of the judging panel on all results shall be final and conclusive. No appeals will be entertained.

Personal Data & Information Collection

- Participants must ensure that all information provided should be true, accurate, complete, and updated without any fraud on submission of personal data, or false submission of personal data of others.
- All information including personal data of the participants will only be used by the Organizer for purposes relating to the scheme, this includes the disclosure and transfer of information to staff, judges, advisors, consultants, the media or other related parties involved in CARS or related activities organized (including but not limited to media interviews) after CARS by Hong Kong SDG Hub or Wofoo Social Enterprises.

Others

- The Organizer reserves the right to amend details relating to CARS (including but not limited to the schedule, assessment process, judging criteria and guidelines) with or without prior notice.
- Participants must abide by all rules and regulations set by the Organizer. Any violation of rules and relations by a team member could lead to the disqualification of the whole team.
- Special arrangements will be rendered if the Organizer cancels the event due to emergencies or unexpected circumstances. The arrangements of CARS are subject to the latest announcement of the Organizer.
- The Organizer reserves the right for the final decision of all disputes and any other matters.
- If there is any inconsistency or ambiguity between the Chinese and English version of the website or other communicated materials, the English version shall prevail.
- Participants have to agree and adhere to all terms outlined in this document for this Scheme. The organizer reserves the right to disqualify participants who fail to conform to these terms or violate any of the above terms.

Part III – Award Arrangement

13. Allocation & Requirements

Climate Action Ideation Award

Winning teams in the Idea Stage League will be awarded HK\$120,000 each to prototype or implement the climate change solutions. The project duration covered by the award should be between six and twelve months.

The award would be allocated to winners in two phases:

First Instalment: HK\$100,000 will be issued after the awardees submit their budget plans, documents outlining and setting project milestones, and a signed agreement.

Final Instalment: HK\$20,000 will be issued after the final report and the company factsheet are received and approved by the Organizer. If necessary, the Organizer may request awardees to submit additional documents for review.

Climate Action Acceleration Award

Winning teams in the Scale-Up Stage League will be awarded HK\$180,000 each to accelerate the growth of their start-ups and facilitate project implementation on combating climate change. The project duration covered by the award should be between twelve and eighteen months.

The award would be allocation to the winners in two phases:

First Instalment: HK\$120,000 will be issued after the awardees submitted their budget plan, documents outlining and setting project milestones, and a signed agreement.

Final Instalment: HK\$60,000 will be issued after the final report and company factsheet are received and approved by the Organizer. If necessary, the Organizer may request awardees to submit additional documents for review.

14. Other Award-Related Terms

- The award may be used for programme set-up, implementation, operation, promotion and other relevant project expenditure subject to the approval of the Organizer. Recipients are not allowed to give away, share or spend the award on irrelevant matters.
- Award recipients have to launch their project within three months of receiving the award.
- Award recipients are required to submit reports and other documents requested by the Organizer during/after the project period. Late submissions risk penalties, e.g. deduction or cancellation of award.
- Person-in-charge of the awarded projects should liaise with the Organizer on the matters relating to CARS and his/her project.
- Award recipients should notify the Organizer if there are changes to the personal details, personnel, operational status, milestones, etc., of the project.
- More details of the award would be disclosed in the agreement.
